Report on June 2019 and July 2019 Financial Statements

\$47,000 over budget for 2018 – 2019. Sped transportation review (17-18) resulted in non-allowance of \$40,000 for special ed transportation funding which affected the budget. Special Education has addressed the issues related to the non-allowance so this will not happen

in the future. Many schools are experiencing the special ed transportation reviews. E-rate payments will be close to \$10,000 which we are still expecting.

We are in the process of enrolling with the open house to be held on Thursday afternoon.
