

501 ADMISSIONS AND LOTTERY POLICY

I. PURPOSE

The purpose of this policy is to clarify the admissions and lottery process at Stonebridge World School.

II. DEFINITIONS

1. **Limits:** Stonebridge may not limit admission to pupils on the basis of intellectual ability, measures of achievement or aptitude, athletic ability, nor may it condition admission on criteria that would violate the Minnesota Human Rights Act.

2. **ApplicationsAdmissions:** Stonebridge shall enroll an eligible pupil who submits a timely application, unless the number of applicants exceeds the capacity of the program, class, or grade level. In such cases, selection shall be by lottery. Once enrolled, a student is considered enrolled until the student formally withdraws or is expelled under the Fair Pupil Dismissal Act.

~~A student continuing for the next year will be re-enrolled for the next year without having to re-apply.~~

III. ADMISSIONS AND LOTTERY PROCEDURES:

1. Admission for Applications Received During Open Enrollment: All applications received during the open enrollment period are automatically admitted (i.e., offered a seat) unless more applications are received than the available capacity established by the Board for the applicable grade(s). If more applications are received than the available seats established by the School Board for the applicable grade(s), all submitted applications for such grade(s) will be placed in the lottery; however, siblings of currently admitted students and a foster child of that pupil's parents have preference. Preference may also be given to children of staff employed at Stonebridge.

2. A person shall not be admitted unless the pupil is at least five years of age on September 1 of the calendar year in which the school year for which the pupil seeks admission commences.

3. Kindergarten enrollment preference will be given to children currently enrolled in Stonebridge's free preschool/prekindergarten program.

4. ~~On March 1 a general lottery will be conducted for each grade level where the number of enrollment applications received exceeds the number of openings. If enrollment applications exceed the openings any remaining slots will be filled by lottery.~~General

Lottery: If the number of applications received during the open enrollment period exceeds available capacity established by the School Board for any grade (and after siblings of enrolled students and foster children of that pupil's parents who submitted timely applications are already admitted, and after all children of staff employed at the school who submitted a timely application are already admitted), the school conducts a general lottery. All applications for each such grade(s) (excluding applications from siblings of already enrolled students or foster children of that pupil's parents and excluding applications from children of staff employed at the school) received before the expiration of the open enrollment period are included in the general lottery. Students are admitted to the school in the order in which they are drawn in the lottery, as long as there is available capacity as determined by the School Board for the applicable grade(s). If all available capacity in any grade is filled, the lottery continues and establishes the general waiting list for each such grade in the order drawn, until all applications are drawn. If a student is admitted through the general lottery and that student has one or more siblings in other grades also subject to a lottery, those siblings are automatically admitted once the student becomes an enrolled student.

5. ~~b. — By lottery from the current applications for that grade in s~~Applications received after the open enrollment period expires are automatically admitted as long as there are available seats as established by the School Board in the applicable grade, in the order received. If, or once, there are no available seats in any grade, applications are added to the applicable waiting list for each such grade, in the order received.
6. The School conducts all lotteries through a method of random selection.
7. The waiting list will expire at the end of the current school year and begin again in January for the next year
8. School Board will determine the number of grade level slots available and the open enrollment period annually prior to the lottery date.

~~After the lottery, their lottery number will place students who are not accepted in the grade level applied for on a waiting list in sequential order. As openings become available students will be contacted and placed.~~
